## GREEN REGULATIONS

1. No vehicles are allowed on the grassy areas of the green, unless for a town function and **ONLY** with permission from the Park Commission. **Vehicles are allowed on concrete areas only.**
2. There are no tag sales allowed on the Green.
3. **NO ALCOHOL** is allowed at any town owned property. This includes Parks, Fields, Parking lots, the Green, and Playgrounds. This includes spectators, and it is up to the organization to control their spectators. If policy is not adhered to organizations will lose the rights to the Green.
4. Organizations are responsible for turning off the power at the end of events.
5. Organizations are responsible for policing Green and placing all garbage in proper receptacles.
6. Effective February 8, 2017, no person shall use any tobacco products, including, but not limited to, smoking cigarettes, cigars, pipes, electronic cigarettes and chewing tobacco in any Borough park, playground, field or during Park and Recreation Department sponsored events. Smoking will be permitted in areas designated for the parking of motor vehicles at Borough parks, playgrounds, fields and Park and Recreation sponsored events.
