Adopted Fees and Policies

Current Policies and Fees for Trash/Recycling pickup are as follows:

The Borough of Naugatuck, Department of Public Works ("DPW"), will supply (at no cost), one 96-gallon recycling cart and one 96-gallon municipal solid waste ("MSW") refuse cart to each housing unit eligible for collection in the Borough.

1. Additional/Replacement Trash cart: \$70.00 plus \$175 yearly service fee (pro-rated at \$14.50 per month) paid in full for the entire year.
2. Additional/Replacement Recycle cart: Free
3. New Construction Home - Trash & Recycle carts: First set Free

3 Tier Penalty for Recycling/Garbage Violations:

- 1st offense – Written warning
- 2nd offense - \$50.00 Service Reinstatement fee
- 3rd offense – \$100.00 Service Reinstatement fee

Transfer Station fees:

Refrigerator/Freezer/AC/Dehumidifier: \$10.00
Stuffed Chair: \$5.00
Loveseat: \$10.00
Sofa/Couch: \$15.00
Tire (Small/Car): \$5.00
Tire (Large/Truck): \$10.00
Small Appliance: \$5.00
Bulk Waste: Approximate Pickup truck Load \$25.00
Household Trash: \$1.00 per regular size bag, \$2.00 per oversized bag
Waterlogged/Damaged Mattresses & Boxsprings: \$25.00
Propane Tanks: 30lb \$10.00

Items accepted at the Naugatuck Transfer Station at no charge:

Mattresses, Boxsprings, Electronics, 20lb Propane Tanks, Brush, Christmas Trees, Leaves in Paper Bags, Automotive Batteries, Motor Oil, Oil Filters, Antifreeze, Hydraulic & Heating Oil, Transmission Fluid, Cooking Oil & Grease, Cardboard, Newspaper, Magazines, Catalogs, Glass and Plastic Bottles, Food Containers, Metal Food & Beverage Cans, Aerosol Cans, Juice & Paperboard Cartons, Juice Boxes, Junk Mail, Boxboard (Cereal style cardboard) Office Paper, Books, Fluorescent Bulbs, Rechargeable Batteries, Fire Extinguishers, Paint, Scrap Metal.
