

Park Commission Special Meeting February 24, 2009

The monthly special meeting was held on February 24, 2009 at the Park Department on Rubber Ave. The meeting was called to order at 5:20pm.

In attendance were Commissioners Pat Wagner, Mike Falcha, Joe Healy and Jay Kuczenski.

Voted: Unanimously on a motion by Mike Falcha and seconded by Joe Healy to accept the minutes of the last meeting.

Business: Superintendent's Report.

Fran stated his staff is working on the equipment and repairing all broken items. His staff is constructing several ticket booths to be placed at the high school for Soccer and Football events. There will be no funding this spring for college student spring help.

Voted: Unanimously on a motion made by Jay Kuczenski and seconded by Mike Falcha to accept Fran's report.

Pat Wagner appointed Jay Kuczenski and Mike Falcha as a sub committee to assist the Elks.

Old Business:

Voted: Unanimously on a motion by Jay Kuczenski to rescind a previous motion to invite all youth organizations to the April meeting and wait till the new guidelines are drafted. Seconded by Mike Falcha.

New Business:

Voted: Unanimously on a motion made by Jay Kuczenski to have the N.J.F.L. move their trailer from the Ambulance Corp. to the NHS upper field no later than April 1, 2009, seconded by Mike Falcha.

Pat and Fran met with the police chief in regards to the skate park being moved in back of the police department with no success. Fran will move the graffiti wall in back of the skate park.

(FYI) A project is being worked on by officers Scofield and Fadanza to put in a handicap park. The Park Commission will look at Legion Field for the request.

Voted: Unanimously on a motion by Jay Kuczenski to let the Renegades use Rotary field for their home games on Sunday morning starting at 9:00am and ending at 11:30am with the understanding they may need to move some home games away, seconded by Mike Falcha.

Voted: Unanimously on a motion by Jay Kuczenski to move the regular monthly meeting starting in May to 6:00 pm, seconded by Mike Falcha.

(Tabled) was a request by Floyd Trevor to request the use of Breen's Field North on Friday nights for softball.

A proposed set of guidelines was past out to all park commission members in attendance to review and bring back for the March meeting with any changes.

Voted: Unanimously to adjourn the meeting at 7:20pm on a motion by Jay Kuczenski, seconded by Mike Falcha.
