Basiliza MacCalmon read the application for Appeal #1955 into the record. The applicant, Robert Cyr, explained that there was a mistake when the foundation was poured. He said it is off by 1'3" which is the amount of the variance they are asking for. He said it was poured 16 feet deep, so it would not be easy to move. Mr. Cyr explained that there are no close neighbors. A discussion endued regarding a solid foundation versus a cantilevered porch. There was no further discussion.
